The SVR Rolling Stock Trust Co Ltd is a registered charity for the restoration and preservation of rolling stock for operation on the Severn Valley Railway. Among the historic carriages now owned by the Trust are five of the SVR's popular LNER varnished teak carriages. Restoring these carriages is a costly and never-ending task – and not funded by your fares! - GIFT AID:**
1. You must pay an amount of income tax or capital gains tax at least equal to the tax that the SVR Rolling Stock Trust Co. Ltd (*Registered Charity 1092723*) reclaims on your donations in the tax year.
 2. Remember to notify us if you no longer pay an amount of income tax and/or capital gains tax equal to that being reclaimed by the Trust Company. Please also notify the Trust Company if you change your name or address whilst the declaration is in force. You can cancel the declaration at any time by notifying the Trust.
 3. If you pay tax at a higher rate you can claim further tax relief in your Self Assessment tax return.
 4. Unsure if your donations qualify? Ask the charity; or obtain Leaflet IR113 Gift Aid from your local tax office.
