# "ACCESS FOR ALL" PROJECT GWR WHEELCHAIR & BUFFET CAR 9581 AN INNOVATIVE RENOVATION & ADAPTATION

Severn Valley's public service trains aim for a mix of first and third class seating along with a buffet car service and a comfortable travel experience for our passengers in wheelchairs and their companions. Aided by some pioneering work by restorers and some Department for Transport grants, this is becoming the norm. But the Great Western set ('GW2') still lacks its own GW buffet car and decent accommodation for our visitors with wheelchairs. At last a suitable vehicle has been found for conversion. This is No.5043, built at Swindon in 1928 as a side corridor, eight compartment, third class coach with gangways and two toilets. Originally out-shopped in GWR chocolate and cream, it probably carried all the livery variants over the years. Nothing is known of 5043's history, and most ex-GWR coaches were scrapped in the 1950s/early 1960s. A few survived as 'departmental vehicles', one being 5043, which was stripped internally and the doors layout altered, becoming a workshop No.DW150301. Later it was bought from BR by the SVR's '2857 Society'. The coach arrived at Bewdley in 1981 to be a workshop for that Society's rebuilding of their GWR 2-8-0 heavy goods locomotive No.2857. With completion of 2857's third overhaul in 2014, and after much modification and rebuilding with new timbers and steel panelling, 5043 became surplus to its owners' needs. The SVR Charitable Trust's *LNER Carriage Group* needed a workshop to complete its LNER Brake Third 24506, and it raised the money for the Great Western (SVR) Association (GWA) to buy the coach with the LNERCG being initially the main user.

The GWA had a long term aim of converting 5043 to a replica Diagram H33 GWR bow-ended dining car – a huge undertaking and possibly surplus to SVR's traffic requirements. But at Kidderminster was another virtually complete bow-ended passenger third No.4786 of 1926 vintage that had survived to become an SVRH-owned dormitory coach familiar to visitors as the 'Camp Coach' that resided at Kidderminster for many years. This too the GWA wished to restore. Some imaginative thinking is allowing both vehicles to be given new lives on the SVR – 4786 to its original as-built design and the already much-altered 5043 to become a wheelchair-friendly coach and accessible buffet car for Set GW2. The ownership of both coaches has been exchanged, the GWA gaining 4786 and 5043 going to SVRH.

**Restoration proposal**: With their experience of major rebuilds (GNR 2701, LNER 24506) and wheelchair accessibility (LNER 24105) the Trust's *LNER Carriage Group* has been asked to undertake the 5043 rebuild as part of SVR's 'Access for All' project. The GVVA will adopt 4786 as its next project, once its similar 6045 is completed. In the rebuilt 5043, central double doors will give access to a large vestibule leading one way to a well-appointed saloon with seats and space for wheelchairs. The other way will lead to a buffet counter with a specially lowered section for wheelchair users. There will also be a wheelchair accessible toilet opening from the central vestibule. The exterior will be steel-panelled with picture windows and sliding vents similar to how most GW catering vehicles were rebuilt in the 1938-52 period to extend their lives. Interior décor will follow that of the final 1938 series of GWR H55 buffet cars with teak veneer panelling to an *art deco* style. On completion 5043 will take the running number of one of the GWR's H33 dining cars and become 9581 in the SVR fleet. As such it will be another interesting example of the SVR's historically important and varied rolling stock collection.
