Please note. This form is only for donations for the improved interior fittings to LNER **Gresley Teak Tourist Third Open carriage No.43612**. This carriage is owned by the Severn Valley Railway Charitable Trust Ltd (Registered Charity 1092723) and was first restored at Bridgnorth for SVR use. It came to the SVR in 1979 from Norwich, but its extensive restoration was not completed until 1996, 33 years after it had last carried passengers. But time and limited resources left the vehicle still with some inappropriate BR fittings. The aim now is to bring this carriage up to the standards of the SVR’s other recent Gresley overhauls.
